Client acknowledges that INS may share their data with authorized third parties, such as government trade regulatory agencies, for the purpose of facilitating my transactions and providing value-added services.

Client is also accountable for the designation of the Users and the Company's availment of the service. It is the sole responsibility of the Client to notify Intercommerce in writing on the activation or termination of the User's access to the system.
