Please be informed that the E2M system is now fully functional and available. To ensure that all goods declaration to be lodged are validated and accepted into the E2M Manifest System, we have adjusted the Estimated Date and Time of Arrival (ETA) on the Arrival Notice of the electronic Manifest (e-manifest) submitted within the period of **05 April 2020 to 07 April 2020**. This is to avoid the imposition of penalty for late submission of manifest considering that the same was occasioned by the technical problems encountered in the e2m.

Our Value-Added Service Providers (VASP) will re-transmit all affected e-manifest to the BOC-VASP Gateway submitted from 05 April 2020 to 07 April 2020. The Deputy Collector for Operations or its assigned personnel must create the Arrival Notice and indicate the estimated date and time of arrival (ETA) to **11 April 2020 at 1:00PM** based on the list provided by our group (*Please refer to Annex A*).
